3.2 PRESENTATION OF FISCAL YEAR 2025 PRELIMINARY BUDGET

Mr. Throne, Director of Public Works, presented two options of the fiscal year 2025 budget. Option A replaces two diesel mowers with diesel mowers while Option B replaces two diesel mowers with electric mowers. Mr. Throne explained Option B is not recommended due to the to the size of the park and lack of infrastructure to charge the electric mowers. Mr. Throne suggested implementing electric mowers at smaller parks first instead of using Harry Griffen Park as a test. Mr. Ornelas, Assistant Director of Public Works stated there are multiple variables that affect the duration of mowing. Currently a high estimate of one charge is six hours but can be as low as two or three.

Board Member Damsky from Helix Water District made a comment that per the City of El Cajon's State of the City address, they have a budget surplus, therefore, Helix Water District requests City of El Cajon return to their original contribution amount.

Board Member Hill from the County of San Diego stated the County cannot accommodate a budget increase over 3%. Mr. Throne pointed out that Option A of the preliminary budget reflects a 1% decrease compared to fiscal year 2024.

Board Member Metschel from the City of El Cajon stated El Cajon stands firm on their current 15% contribution amount.

3.3 REPORT FROM CANINE CORNERS OFF-LEASH DOG RUN

Nick Giacchina, Treasurer, spoke on behalf of the Canine Corners off-leash dog run. He stated the most recent improvement was the repair of the fence that separates the small and large dog areas. Also, they are currently working on a schedule of events for 2024. He said Canine Corners is looking to revise their improvement projects to account for the rise of costs within the past few years. Some of those projects include regrading inside the dog park with City of La Mesa's assistance, making drainage modifications to mitigate sand erosion and possibly the installation of a prefabricated bridge between the grass and dog park entrance. Mr. Giacchina was unable to answer Board Member Arapostathis' question regarding the square footage of the dog park.

SUMMARY:

Issue(s):

Should the Harry Griffen Regional Park Joint Powers Agreement Governing Board approve the draft Fiscal Year 2025 Budget?

Recommendation:

That the Harry Griffen Regional Park Joint Powers Agreement Governing Board review and approve the draft Fiscal Year 2025 Budget.

BACKGROUND:

In 1979, the Harry Griffen Regional Park Joint Power Agreement was formed to serve as the operating framework for the development, operation and maintenance of Harry Griffen Regional Park. Each year the Governing Board, comprised of appointed representatives from the cities of El Cajon and La Mesa, the County of San Diego, the Grossmont Union High School District and the Helix Water District, meet to discuss and vote on current and future improvement projects, park concerns and an annual budget.

DISCUSSION:

On March 5, 2024, a preliminary budget for Fiscal Year 2025 was presented to the Governing Board. The Governing Board discussed budget options, and unanimously approved a preliminary budget that includes the purchase of a diesel mower. Based on the Governing Board's direction, the attached draft Fiscal Year 2025 Budget has been prepared.

RE: Harry Griffen Regional Park Proposed Budget FY 2024-2025

Dear Board President Arapostathis,

On March 5, 2024, the Harry Griffen Park JPA met to consider two preliminary budget options for fiscal year 2024-25. The two options presented by city staff included the purchase of two new lawn mowers for the park: one stand-on and one ride-on mower. Option A, which the JPA recommended the city implement, included the purchase of diesel-powered mowers resulting in a total estimated budget savings of \$59,680 compared to option B, which included battery-powered mowers.

It has since come to our attention that the purchase of diesel-powered mowers included in budget option A may run counter to the objectives outlined in the city of La Mesa, El Cajon, and county of San Diego's climate action plans. Helix Water District is committed to supporting jurisdictional climate action plans where feasible to move towards a more sustainable future. Therefore, we strongly encourage the JPA to reconsider the preliminary budget options and redirect staff to implement budget option B, which incorporates the purchase of battery-powered mowers and better aligns with the broader sustainability objectives.

It is requested that city staff attend the April 15 JPA board meeting to discuss the budget and mower options in greater detail, including how each option impacts the climate action plan objectives established by the various member JPA agencies. In its evaluation, the city may consider available grants and/or rebates that would better bridge the cost difference between the battery and diesel-powered mower options. Potential funding sources to consider include the Inflation Reduction Act, the San Diego County Air Pollution Control District Carl Moyer funding source, and the California Clean-off Road Equipment Voucher Incentive Project.

The Helix Water District Board of Directors recognizes and applauds the effort city staff has made to minimize operational costs. However, after consideration of the broader scope of our responsibility to be good stewards of the environment, we are in support of reasonable operational decisions that support greenhouse gas reduction goals as outlined in the state of California, cities and county's climate action plans. We encourage and support the operational accommodations made by the Harry Griffen Park JPA to serve as a positive role model and exemplify our commitment to sustainability within the communities we serve.
