10. STAFF REPORTS - CITY COUNCIL - PUBLIC FINANCING AUTHORITY - SUCCESSOR AGENCY

10.1 CONSIDERATION OF THE BIENNIAL BUDGET FOR 2023-2025

City Manager Humora provided a brief overview of the biennial budget process and announced it was the first year the City was using the new OpenGov financial software to prepare the budget. City Manager Humora summarized the initiatives that would be implemented and those that would continue with the proposed budget, which included the expansion of the Homeless Outreach and Mobile Engagement (HOME) program, continued implementation of the Climate Action Plan, preparation of the environmental impact report for Waite Drive Park, completing the next phase of the Collier Park improvements, continuation of the Vision Zero policy, updating the strategic planning process, continued construction of

the 100% affordable housing project at 8181 Allison Avenue, and continued improvements to the private development process.

Finance Director Royales gave an overview of the 2023-2025 Preliminary Budget, highlighting the new budget system, the budget process, the Citywide revenue and expenditure funds, the General Fund revenues and expenditures, CalPERS Retirement contributions, the staffing changes reflected in the Preliminary Budget, the Council's General Fund Reserve Policy, and the General Fund Reserves.
