SUBJECT: A. RESOLUTION ACCEPTING BID 24-05, 2023 STREET RESURFACING PROJECT AND AWARDING A CONSTRUCTION CONTRACT TO QUALITY CONSTRUCTION & ENGINEERING, INC.

B. RESOLUTION AWARDING A TASK ORDER TO ARDURRA GROUP, INC. TO PROVIDE CONSTRUCTION MANAGEMENT AND INSPECTION SERVICES FOR THE 2023 STREET RESURFACING PROJECT

SUMMARY:

Issues:

Should the City Council approve the attached Resolutions:

- A. Accepting Bid 24-05, 2023 Street Resurfacing Project and awarding a construction contract to Quality Construction & Engineering, Inc. in the amount of \$2,113,403.85?
- B. Awarding a task order to Ardurra Group, Inc. to provide construction management and inspection services for the 2023 Street Resurfacing Project in the amount of \$67,589.00?

- B. Awarding a task order to Ardurra Group, Inc. to provide construction management and inspection services for the 2023 Street Resurfacing Project in the amount of \$67,589.00.

City's Strategic Goals:

- Invest in infrastructure to serve the needs of the community.
- Maintain a community where residents and visitors feel safe.
- Ensure a strong financial outlook through careful planning, sustainable service levels, and fiscal sustainability.

BACKGROUND:

The City of La Mesa maintains roadways on a 7-year, 7 zone cycle. Roadways are selected based on multiple factors including: Average daily traffic, types of vehicle load, paving history, types of roadway damage, and more. This year's resurfacing is in multiple maintenance zones due to roadway damage, utility repairs, and various other factors (see Attachment E).

In April 2018, the City advertised a request for qualifications (RFQ 18-15) and held a formal selection process to select highly qualified firms that could provide various services. Ardurra Group, Inc. was selected to provide construction management inspection services. The terms of the Master Agreement allows for the issuance of task orders to authorize specific items of work on an as-needed basis to the selected consultants.

DISCUSSION:

On October 24, 2023, a notice inviting bids was advertised and bid documents were distributed. On January 9, 2024, two bids were received electronically. The apparent responsive, responsible

low bidder was identified as Quality Construction & Engineering, Inc. with a base bid of \$1,797,368.63 plus alternate bid price of \$316,035.22 for a total bid price of \$2,113,403.85 as shown on Bid Tabulation, Attachment D.

The 2023 Street Resurfacing Project has sufficient funds in Road Maintenance & Rehabilitation Accounts, Street Reconstruction, and Regional Arterial Improvements CIP accounts for the base bid and alternate bid received from Quality Construction & Engineering, Inc. in the amount of \$2,113,403.85. Contract time for completion of the project is 60 working days. The work is expected to begin in April of 2024 and be completed by July of 2024.

Ardurra Group, Inc. has provided a scope of services to manage, monitor and inspect the construction of the project and will be reporting to the City's project manager. The fee quoted from Ardurra Group, Inc. to perform Inspection and CM services is \$67,589.00.

CONCLUSION:

Staff recommends that the City Council adopt the attached Resolutions:

- A. Accepting Bid 24-05, 2023 Street Resurfacing Project and awarding a construction contract to Quality Construction & Engineering, Inc. in the amount of \$2,113,403.85
- B. Awarding a task order to Ardurra Group, Inc. to provide construction management and inspection services for the 2023 Street Resurfacing Project in the amount of \$67,589.00.


