




Crime Trends and Statistics

The 4th quarter of 2023 concluded with 20.6 crimes per thousand residents compared to 23.8 crimes per thousand in the 4th quarter of 2022, which represents a 14% decrease in the number of crimes. During this period violent crime increased 31.4% and property crime decreased 20.8%.

While incidents of homicide remained relatively the same compared to last year, incidents of rape, robbery and aggravated assault increased. All rapes reported in the 4th Quarter


of 2023 were committed by an individual known to the victim. Fifty-six (56) percent of aggravated assaults were domestic violence related during the 4th quarter of 2023. Overall, the total number of robberies committed in 2023 year-to-date increased 36.2% compared to 2022. Forty (40) percent of all robberies were closed by arrest year-to-date in 2023.

Case Clearances

In December 2023 there was a series of robberies at gas stations and liquor stores across the County. Over the course of a single night during this series, the suspects targeted 11 stores in La Mesa, Santee, San Diego, Spring Valley, Lakeside and Escondido. Through the collaboration of the law enforcement community, the suspects were identified and arrested. In total they were responsible for over 25 cases in San Diego County. Three La Mesa businesses were targeted in this series. Prosecution of this case is ongoing.

On November 17, 2023, a victim was robbed at gunpoint in the 6800 block of Century Street in La Mesa. The victim arranged to purchase a PlayStation 5 (PS5) from an individual selling the gaming console on Facebook Marketplace. When the victim met with the seller, the seller produced a handgun and demanded money from the victim. After the victim complied, the suspect fled on foot. La Mesa Police Detectives were able to identify the suspect, a 16-year-old resident of Poway, and learned he was arrested in San Diego a week after the robbery and a firearm was recovered during that arrest. Detectives submitted additional charges on the juvenile to the Juvenile District Attorney. Prosecution of this case is ongoing.

Compared to the previous year, residential burglary increased 43.5%, commercial burglary decreased 21.2%, theft decreased 29.4%, and auto theft decreased 1.1%.

Case Clearances

On December 2, 2023, a residential burglary occurred in the 7400 block of Eastridge Drive while the residents were at home. Credit cards stolen during the burglary were subsequently used at numerous business in San Diego County. Through review of surveillance footage provided by neighbors, and businesses where the suspect made fraudulent purchases, investigators were able to identify the license plate of the vehicle associated with the burglary. Two subjects were identified; it was determined that they were residents of Lake Elsinore, California. Additional related cases that had occurred in San Diego and La Mesa were identified through investigative leads. One of the two suspects was contacted by law enforcement within the County and the La Mesa Detective was notified. The suspect was transported to La Mesa Police station for questioning and subsequently arrested for three cases of burglary and auto theft. He was booked into Central Jail. Other local agencies have since booked the suspect with charges related to additional cases. Recovered stolen property has been returned to victims in La Mesa as well as in Riverside County.

During the months of November and December, a wanted subject was breaking into vacant residences at the District Apartments, located at 8728 Fletcher Parkway. The subject was wanted for burglary and identity theft related charges and was aware that he had a felony arrest warrant. On two previous occasions, the subject fled from La Mesa Police Officers, evading arrest by jumping out a second story window of an apartment he had broken into. On Monday, December 11, 2023, a manager of the apartment complex at 8515 Chloe Avenue called to report a subject inside a vacant unit at the complex. La Mesa Police Officers responded, established a perimeter to prevent the subject from evading arrest, and attempted to call the subject outside. The subject refused to exit the apartment and indicated that he would respond with violence if officers tried to arrest him. The Special Response Team was activated, along with Crisis Negotiators, and a 4-hour stand-off ensued. The subject was ultimately taken into custody and arrested for his felony warrant and additional charges related to the La Mesa burglary cases and felony resisting a peace officer. No injuries were sustained by the involved officers or the subject.

Supervised Persons in the City

Registered Sex Offenders

There are currently ninety-nine (99) active sex registrants in the city, seven (7) of whom are transient individuals. Throughout the year, patrol officers conduct compliance checks on the registrants living in La Mesa. Two (2) registrants were out of compliance during the 4th Quarter of 2023, meaning they have not completed their annual or monthly check-in and residency verification as required.

On October 4th, the La Mesa Police Department hosted Coffee with a Cop at Brew Coffee Spot for National Coffee with a Cop Day. The Department looks forward to these quarterly gatherings with the community to address concerns and engage in dialog.

On October 5th, the La Mesa Chamber of Commerce honored men and women from police, fire, and EMS that serve our community at the 15th Annual Salute to Local Heroes event. Detective Jamie Roberts, Officer Hannah Rost, Downtown Operations Assistant Slawomir Stojanowski, and Retired Senior Volunteer Clarke Stillwagen were the 2023 honorees.

During the 4th quarter, the Department hosted the 2023 Citizen's Academy. La Mesa Police Department's Citizens' Academy is a free six-week program, where attendees participate in discussions about patrol procedures, traffic investigations, community policing and many other topics. The Department hosted 15 attendees during the academy.

On October 28th, La Mesa Police, in partnership with the DEA, hosted a Drug Take Back day in the parking lot of the station. This recurring event helps La Mesa residents dispose of unused and expired medication safely.

Every year on the first Saturday in December, La Mesa Police Department volunteers with law enforcement agencies countywide to take local underprivileged kids on a holiday shopping trip for free. Nominated by their schools, the kids are taken to Sea World for breakfast and then to Target where they are given a \$200 gift certificate to shop for the holidays. The 28th annual Shop with a Cop event was held December 3rd and sponsored 300 kids from across the County. The region's law enforcement agencies raise money for the event by



Department Wellness

The Department remains committed to the wellness of our staff and we offer a variety of resources to our police officers and professional staff. Our Peer Support Team responded to several call-outs during the past quarter to support staff who were impacted by critical incidents. Our Facility Dog, Declan, has also been called upon to provide his unconditional love and support to those team members impacted by trauma, stress, and the often-challenging realities of first responder work. The La Mesa Police Department contracts with a local mental health clinician who is culturally competent in assisting first responders

with processing life and work trauma. This clinician is an invaluable asset and helps us protect our people so they can continue to protect you.

Racial and Identity Profiling Act (RIPA) Reporting

The Racial and Identity Profiling Act of 2015 prohibits racial and identity profiling by law enforcement, and requires all agencies to annually report vehicle and pedestrian stop information, as well as citizen complaints of profiling, to the California Attorney General's Office. The La Mesa Police Department began collecting stop information in 2022 in compliance with the legislation. Data for 2022 was reported to the Department of Justice at the beginning of the 2nd Quarter of 2023 and data for 2023 will be reported to DOJ during the 2nd Quarter of 2024. California Incident Based Reporting

Historically, the La Mesa Police Department has reported crime statistics using the Uniform Crime Reporting (UCR) Summary Statistics program with the FBI. California and the nation have now transitioned to new standardized reporting systems: the California Incident Based Reporting System (CIBRS) and the National Incident Based Reporting System (NIBRS). These new systems allow for robust reporting of fifty-two offense types, an increase from 8 offense types under UCR. Reported data includes case detail information to more accurately analyze crime trends state-wide and nationally. The La Mesa Police Department will begin reporting quarterly crime statistics to the public in CIBRS format beginning in the 1st quarter of 2024. UCR statistics will continue to be published for historical comparison.
