RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LA MESA
ACCEPTING BID NO. 23-15, CITYWIDE GUARDRAIL UPGRADES AND
AWARDING A CONSTRUCTION CONTRACT TO SB GENERAL
ENGINEERING, INC.

WHEREAS, the City of La Mesa continues to improve high quality municipal services and revitalize neighborhoods and corridors;

WHEREAS, on September 25, 2018, the City adopted a Vision Zero Plan to reduce traffic fatalities to zero and prioritize safety within infrastructure projects and combine education and enforcement practices to achieve this goal;

WHEREAS, on October 23, 2020, the City of La Mesa secured Highway Safety Improvement Program (HSIP) Grant Funding in the amount of \$434,300 for the replacement, repair, and enhancement of guardrail throughout the City of La Mesa;

WHEREAS, the project under consideration is consistent with the City's Vision Zero Plan;

WHEREAS, on April 12, 2023, bid 23-15 was advertised and low bid selection was based on the lowest responsive, responsible base bid;

WHEREAS, on May 2, 2023, the City received One bid and SB General Engineering, Inc. was the lowest, responsive, responsible bidder with a total base bid amount of \$422,738; and

WHEREAS, the total bid is within the City's budget.

NOW, THEREFORE, BE IT AND IT IS HEREBY RESOLVED by the City Council of the City of La Mesa, California, that:

SB General Engineering, Inc.'s base bid in the amount of \$422,738 for Bid No. 23-15, Citywide Guardrail Upgrades was determined to be the lowest, responsive, responsible bid. Said bid is on file in the Office of the City Clerk.

BE IT FURTHER RESOLVED that the Mayor is hereby authorized to accept and execute a construction contract with SB General Engineering, Inc. to perform items of work at the prices set forth in said bid for a total bid award amount of \$422,738.

BE IT FURTHER RESOLVED that the Director of Public Works/City Engineer is authorized to approve the substitution of subcontractors.
