RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LA MESA APPROVING AN AWARD AND PROFESSIONAL SERVICES AGREEMENT IN SUBSTANTIAL FORM AS PRESENTED, SUBJECT TO THE FINAL REVIEW AND APPROVAL OF THE CITY ATTORNEY, FOR REQUEST FOR PROPOSALS 22-13 FOR CLIMATE ACTION PLAN AMENDMENT NO. 2 CONSULTING SERVICES TO THE UNIVERSITY OF SAN DIEGO ENERGY POLICY INITIATIVES CENTER FOR THE TOTAL AMOUNT OF \$100,000

WHEREAS, in March 2018, the City of La Mesa approved the Climate Action Plan (CAP), which charts a course to reduce community-wide greenhouse gas (GHG) emissions by 15% by 2020, and 53% below 2010 levels by 2035 and serves as a long range road map with measures and key actions to implement in energy, transportation, solid waste, water, and green infrastructure;

WHEREAS, the CAP Implementation Team, led by the Environmental Program Manager and made up of representatives from key departments within the City, have been working collaboratively to coordinate and implement CAP measures and report progress;

WHEREAS, the CAP is scheduled to be updated in 2023;

WHEREAS, on August 2, 2021, the City Council created the Climate Action Plan Ad Hoc Subcommittee (CAP Subcommittee) to discuss recommendations for the 2023 CAP update;

WHEREAS, on January 25, 2022, the CAP Subcommittee recommendations were presented and approved by City Council;

WHEREAS, the scope of the CAP update includes public engagement, CAP revisions, and plan adoption;

WHEREAS, on March 31, 2022, the City requested proposals for Climate Action Plan Amendment No. 2 Consulting Services;

WHEREAS, on April 18, 2022, one proposal was received and subsequently evaluated;

WHEREAS, University of San Diego Energy Policy Initiatives Center (EPIC), was found to be the most highly qualified firm and was recommended for contract award based on their proposal and interview; and

WHEREAS, a final scope of work and fee were negotiated with EPIC to provide Climate Action Plan Amendment No. 2 consulting services.

NOW, THEREFORE, BE IT AND IT IS HEREBY RESOLVED by the City Council of the City of La Mesa, California, that the Mayor is hereby authorized to approve an award and professional services agreement in substantial form as presented, subject to the final review and approval of the City Attorney, with the for Request for Proposals 22-13 for Climate Action Plan Amendment No. 2 Consulting Services to the University of San Diego Energy Policy Initiatives Center for the total amount of \$100,000.
