Should the City Council accept Bid 25-03, Pipe Rehabilitation Project and award a construction contract to Insituform Tech, Inc. in the amount of \$288,679?

BACKGROUND:

Three segments of wastewater and stormwater pipes were identified to be maintained this fiscal year: 430 linear feet of wastewater pipe in Keeney Canyon, 170 feet of stormwater pipe near Golondrina Drive, and 30 feet of stormwater pipe on Lee Avenue.

The project will maintain the pipe segments using cured in place pipe (CIPP) lining. CIPP lining is a trenchless technology used to extend the life of wastewater and stormwater conveyance pipes up to sixty years.

DISCUSSION:

On July 11, 2024, the City posted a notice inviting bids and documents were distributed to 30 registered plan holders on the Planet Bids portal. On August 1, 2024, the City received two bids electronically. The lowest responsible bidder was Insituform Tech, Inc. with a bid amount of \$288,679. A summary of bid results is shown in Attachment B.

Contract time for completion of the project is 60 working days. The work is tentatively scheduled to begin in September 2024 and be completed this fall. The City will notify the affected properties of the planned work and additional notices will be provided prior to the start of the construction.

CONCLUSION:

Staff recommends the City Council adopt the attached resolution accepting Bid 25-03, Pipe Rehabilitation Project, and awarding a construction contract to Insituform Tech, Inc. in the amount of \$288,679.
