RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LA MESA AUTHORIZING A PURCHASE AGREEMENT WITH BEAM GLOBAL FOR SOLAR POWERED ELECTRIC VEHICLE CHARGING STATIONS

WHEREAS, in March 2018, City Council approved the Climate Action Plan (CAP), which charts a course to reduce community-wide greenhouse gas (GHG) emissions;

WHEREAS, as part of the CAP, the City is committed to reducing GHG emissions from the transportation sector, which is the largest emitter of the community-wide GHG emissions;

WHEREAS, in April 2024, City Council approved Resolution 2024-035 authorizing the application an acceptance of funding for the Energy Efficiency and Conservation Block (EECBG) grant to fund and purchase Beam Global solar-powered EV charging stations (EV ARCs);

WHEREAS, in June 2024, two EV ARCs were purchased and the assembly of the units are in production;

WHEREAS, in August 2024, the La Mesa Park & Recreation Foundation was awarded funds by the San Diego Community Power Clean Energy Grant Program to purchase one Beam Global solar-powered EV charging station;

WHEREAS, the EV ARCs would be made available to the public, encouraging the increased adoption of electric vehicles powered by renewable energy;

WHEREAS, the purchase agreement with Beam Global will include the purchase of the third EV ARC and the Remote Monitoring and Management System (RMMS) for an additional 9 years (for a total of 10 years) and Manufacturer Warranties for additional 4 years (for a total of 5 years) for all three EV ARCs;

WHEREAS, the cost for the purchase agreement is \$82,516, in which \$72,226 will be reimbursed by grant funds awarded to the La Mesa Park & Recreation Foundation by the San Diego Community Power Clean Energy Grant Program; and

WHEREAS, the purchase agreement of \$82,516 does not include tax, and the tax, RMMS and manufacturer warranties will be charged to the Environmental Services account in the amount of \$16,817.21.

NOW, THEREFORE, BE IT AND IT IS HEREBY RESOLVED by the City Council of the City of La Mesa, California, that that the City Council authorizes a purchase agreement with Beam Global for solar powered electric vehicle charging stations.

BE IT FURTHER RESOLVED that the City Manager or a designee is authorized and to execute and submit all documents, including, but not limited applications, agreements, amendments, and so on, for all documents and forms necessary to implement and carry out the approved activities.
