# **Public Hearing Information**

At the Public Hearing, the City Council will hear and consider all testimony concerning the proposed increases to the solid waste rates. If you oppose the proposed rate increase, your protest must be submitted in writing to be considered. Oral comments at the Public Hearing will not qualify as a formal protest unless accompanied by a written protest. If written protests are submitted by a majority of affected property owners, the proposed rate increases may not be implemented.

<u>Protests must be submitted in writing</u> to the City Clerk's office by noon on Tuesday, June 24, 2025.

Owners of multiple properties must file a separate written protest for each property. Only one written protest per parcel will be accepted.

Protests sent by e-mail or fax will not be accepted.

Protests received after the Public Hearing is closed also will not be accepted.

Written protests must contain a statement indicating your opposition to the rate increase, the Accessor Parcel Number (APN) of the property subject to the proposed rates, the EDCO service address, and the printed name and the signature of the property owner or rate paying tenant. # Why are Solid Waste and Recycling Rates Increasing?

EDCO Disposal Corporation provides solid waste disposal, recycling services, and organic waste recycling services in the City of La Mesa under a franchise agreement. These services include the

collection, transfer, processing, and disposal of all solid waste, recyclables, and organic waste generated at all residential and commercial properties located in the City of La Mesa.

In an effort to stabilize trash and recycling rates paid by EDCO customers in La Mesa over the long term, the La Mesa City Council began adopting multipleyear rates in 1997.

The current solid waste rates have been in effect since July 1, 2023.

In accordance with the franchise agreement, EDCO is required to submit a written request for any rate adjustments for the upcoming fiscal year.

Prior to presenting any new rates for Council consideration, the City contracts with an independent accounting firm to perform certain agreed-upon procedures on EDCO's accounting records. This work includes reviewing detailed worksheets that track EDCO's costs and revenues for each rate component. The worksheets are ultimately used to calculate the proposed rates. The purpose of having the agreed-upon-procedures performed is to assist City staff in determining the appropriateness of rates charged to La Mesa's citizens and businesses for the collection of trash and recyclable materials.

Following the independent accountant's work, EDCO and City staff, with assistance from the accountants, negotiate appropriate final rates for the City Council to consider during a Public Hearing. If approved at the June 24, 2025 Public Hearing, rate adjustments will be effective starting July 1, 2025.

The proposed rate adjustments are needed to fund cost increases for collecting, processing, and disposing of solid waste, labor and equipment costs, fuel charges, recyclable collection and processing, public education, and other state-mandated landfill diversion programs.
