## Law Enforcement Operations and Statistics

#### Part 1 Crimes and Statistics

The 4th quarter of 2021 concluded with 21.7 crimes per thousand residents compared to 20.0 crimes per thousand in the 4th quarter of 2020, which represents a 7.1% increase in the number of crimes.

Violent Crimes decreased 3.9% in 2021 year-to-date compared to the same period in 2020. There were 174 incidents at the end of the 4th quarter of 2021 compared to 181 in 2020. Robberies decreased 22.4% in 2021 year-to-date compared to the same period in 2020. During the 4th quarter of 2021 there were 12 robberies compared to 16 during the 4th quarter of 2020.

Property Crimes increased by 9.1% in 2021 compared to 2020. At the end of the 4th quarter of 2021, there were 1130 property crimes reported compared to 1036 at the end of the 4th quarter of 2020. The following three categories make up the category of Property Crime: Burglary, Theft and Auto Theft. Burglary decreased 24.9%, Theft increased 18.5% and Auto Theft increased 20.8%. This category also includes a 32.7% increase in vehicle burglaries, an 11.5% increase in residential burglaries, and a 46.6% decrease in commercial burglaries.

The following is a significant robbery clearance from the 4th quarter:

 On 12/3/21, LMPD Patrol officers responded to the California Coast Credit Union regarding a bank robbery which had just occurred. Patrol officers arrived in the area within minutes and located the suspect a couple of blocks away from the bank. FBI Agents from the San Diego Field Office arrived on scene and assisted officers with the investigation. The suspect was ultimately placed under arrest for 211 PC - Robbery and transported to San Diego Central Jail where he awaits trial. All of the stolen money was recovered at the scene.

The following are some of the significant burglary clearances from the 4th quarter:

 On 8/29/21, a resident reported her purse had been stolen from her unlocked vehicle overnight. The victim received several notifications from her bank that her credit cards had been used at various stores in the county. Detectives from the La Mesa PD's Special Investigations Unit (SIU) conducted follow-up at one of the businesses where the victim's card had been used. After viewing surveillance footage, detectives were able to obtain the license plate number for the suspect's vehicle. After checking the plate through law enforcement databases, SIU Detectives learned the vehicle had been involved in two additional theft cases in San Diego County. The suspect from those thefts matched the suspect in the video surveillance. On 9/30/21, SIU Detectives were notified by their counterparts from the San Diego Sheriff's Department that the suspect had been arrested for an unrelated crime. SIU Detectives arrived at San Diego Central Jail and added charges of 530.5 PC-Identity Theft and 459 PC- Burglary, related to the La Mesa cases.

 On 11/10/21 at 2:01 AM, Grossmont Center security was monitoring video surveillance of the property. An unknown subject appeared on the video and attempted to force entry into a storage area. Security personnel quickly contacted La Mesa Police and provided dispatchers with the suspect's license plate number. Patrol officers responded and were able to locate the vehicle a few blocks away from the mall. Two suspects were arrested for 459 PC Commercial Burglary and 182(A)(1) PC – Conspiracy.



#### AB109 – Public Safety Realignment

The California criminal justice system had a fundamental shift on October 1, 2011, as the result of Assembly Bill 109, the Public Safety Realignment Act. The law changed a number of ways Law Enforcement monitors these offenders. Felons who have committed non-violent, non-serious, and non-sex offenses are housed in county jail. Those released from state prison, known as Post Release Offenders (PRO), are supervised by the Probation Department. Probation violations by the PRO population are served in county jail and are limited to 180 days.

According to the San Diego County Probation Department, La Mesa currently houses thirteen (13) of the Post Release Offenders.

#### Registered Sex Offenders

There are currently eighty-eight (88) active sex registrants in the city and all are in compliance. Throughout the year, patrol officers conduct compliance checks on the registrants living in La Mesa.

#### Traffic Collisions/Citations/Enforcement Operations

There were seventy five (75) traffic collisions during the 4th quarter of 2021. Of the seventy-five (75) reports, thirty-eight (38) collisions involved injuries with fifty-three (53) total drivers and passengers reporting injuries. Of the fifty-three (53) injured parties, there was one (1) serious injury collisions and zero (0) fatalities.

#### Traffic Enforcement Operations

During the 4th quarter, the Traffic Unit conducted four (4) DUI Saturation Patrols, three (3) Primary Collision Factor Operations, and one (1) DUI Checkpoint.

"Photographed Graffiti" includes graffiti photographed by Public Works and Police Department personnel.

The Community Resource Unit (CRU) receives reports of graffiti from RSVP patrols, the Graffiti Hotline, the city's SeeClickFix, phone calls from citizens to the Police Department, and reports of graffiti to Public Works. CRU continues to work with several volunteers and private businesses in an effort to assist in graffiti eradication. CRU has worked with Code Compliance on properties that are chronic graffiti targets.

During the 4th quarter of 2021, locations with a high frequency of graffiti included City parks and the 5800 block of Jackson Drive.

#### School Resource Officer

The SRO is position is currently vacant.

#### Crime Prevention/Emergency Preparedness

There are currently 115 Neighborhood Watch groups. The Nextdoor.com social media group has approximately 20,072 La Mesa citizens participating. The Department's Facebook account has 6,593 followers. The Department's Twitter account has 4,975 followers. The Department's Instagram account has 3,222 followers.

During the 4th quarter, Crime Prevention coordinated one Coffee with a Cop, a Drive-Thru Halloween event, and a Citizen's Academy.

<sup>5</sup> The Homeless Outreach and Mobile Engagement (HOME) is an initiative of the City of La Mesa, in collaboration with the La Mesa Police Department. The HOME program was officially relaunched at the end of 2021 when City outreach workers became the sole service providers. Beginning January 1, 2022, LMPD Dispatchers now route the HOME team as primary responders to non-emergency calls for service that do not require a police presence. Prior to this change in dispatching, the team responded to requests for service through phone calls to the HOME hotline, email, or via printouts of calls to the PD's communication center.
