




Crime Trends and Statistics

The 3rd quarter of 2022 concluded with 23.3 crimes per thousand residents compared to 22.2 crimes per thousand in the 3rd quarter of 2021, which represents a 5.2% increase in the number of crimes. During this period violent crime decreased 1.5% and property crime increased 6.3%.

Historical Violent Crime Comparison, 3rd Quarter Year to Date




While incidents of homicide, rape and aggravated assault decreased compared to last year, incidents of robbery increased. This is due in part to an increase in shoplifting cases where suspects fought with employees, resulting in a robbery.

Case Clearances

Between 07/16/22 and 07/21/22, the same unknown suspect robbed two gas stations and two convenience stores in La Mesa and El Cajon. The suspect would simulate holding a weapon in the front pocket of his sweatshirt and demand cash from the clerk. Detectives from the respective police departments were able to link the cases together through "Be on the Lookout" flyers shared countywide. Using investigative leads, the suspect was identified, arrested for the robberies, and sentenced to 8 years in prison.

On 07/19/22 at approximately 4:30 PM, a male suspect walked behind the counter at the Denny's located at 4235 Spring Street, simulated holding a weapon in his sweatshirt pocket and demanded a server open the cash register. The suspect fled on foot with the cash drawer. La Mesa patrol officers responded to the restaurant and began a search for the suspect. With detailed descriptions of the suspect from the victim and witnesses, as well as assistance from the Metropolitan Transit System (MTS) security, patrol officers were able to locate the suspect in the 3900 block of Quarry Road. The suspect was arrested and booked into jail for robbery.

On 07/24/22 at approximately 11:00 PM, the victim was robbed and carjacked by gunpoint in the parking lot of the Vons located at 8011 University Avenue. Patrol officers responded and canvased the area. Officers contacted MTS security and obtained surveillance video of subject matching the description of the subjects at the La Mesa Boulevard trolley stop. A bulletin with the suspects photos was distributed countywide. A possible lead was developed and the victim's vehicle was located near the identified suspect's home. The Regional Auto Theft Task Force conducted a warrant search on the suspect's home and found additional evidence linking the suspect to the carjacking. He was arrested and booked for carjacking and robbery.



Historical Property Crime Comparison, 3rd Quarter Year to Date

Compared to the previous year, during the 3rd quarter, residential burglary decreased 35.5%, commercial burglary increased 33.9%, theft increased 9.7% and auto theft increased 3%. Theft increased during 2022 year to date, in part, due to increases in the theft of motor vehicle parts and accessories such as catalytic converters and license plates, as well as an increase in reported shoplifting cases.

Case Clearances


On 08/03/22, at approximately 3:45 AM, La Mesa patrol officers responded to a commercial burglary alarm at Dixieline, located at 8372 Center Street. Upon arrival, officers discovered that a lower left front window had been smashed and an interior security fence was damaged. Surveillance video provided to officers, showed the suspect entering and exiting the business. As officers were establishing a perimeter around the business, the suspect was located walking down Center Street. The suspect was taken into custody without incident and booked into jail for burglary and vandalism.

On 09/14/22, just after midnight, La Mesa patrol officers responded to a commercial burglary in progress at the Cal Coin and Jewelry Store located 9019 Park Plaza Drive. Officers discovered a hole had been cut into the wall of the business from the empty, adjacent business suite of the strip mall. Officers searched the surrounding area and located an individual walking down Fletcher Parkway with drywall in his hoodie. The suspect was arrested and booked into jail for burglary.

School Resource Officer

The School Resource Officer (SRO) attended crisis de-escalation training for FTO's, crisis de-escalation training for SRO's, and the San Diego Regional School Resource Officer two-day training. The SRO has established strong working relationships with all of the Principles, with Helix' Executive Director, with the La Mesa Spring Valley School District Director of Public Safety, and with the Grossmont Union High School District Director of Public Safety.

At Helix Charter High School, the SRO:

- Coordinated with the Traffic Unit for traffic enforcement at the beginning of the school year,
- Completed threat assessments and conducted several "home visits" with students,
- Provided police services during football games,
- Worked after hours with LMPD night shift officers and simultaneously with Helix school administrators on a vague school threat.

In service to the middle and elementary schools, the SRO:

- Provided information during a "Secure Campus" incident for nearby police activity not related to the schools,
- Worked with school principals, parents, and students in regards to bullying education,
- Coordinated with the Traffic Unit for traffic enforcement at the beginning of the school year.


There were no promotions in this quarter.

Our Peer Support Team responded to several call-outs during the past quarter to support staff who were impacted by critical incidents. Our Facility Dog, Declan, has also been called upon to provide his unconditional love and support to those team members impacted by trauma, stress, and the often-challenging realities of first responder work. The La Mesa Police Department contracts with a local mental health clinician who is culturally competent in assisting first responders with processing life and work trauma. This clinician is an invaluable asset and helps us protect our people so they can continue to protect you.

The HOME program was officially relaunched on November 1, 2021 when City outreach workers became the sole service providers. As part of the relaunch, LMPD Dispatchers now route the HOME team as primary responders to non-emergency calls for service that do not require a police presence.
